AN ORDINANCE

An Ordinance of the County of Allegheny, Commonwealth of Pennsylvania authorizing the Chief Executive to execute a deed conveying the County of Allegheny's interest in a parcel jointly owned by the County of Allegheny, the Borough of Emsworth and Avonworth School District to Joseph and Barbara Cicchelli.

WHEREAS, the County of Allegheny, Emsworth Borough and the Avonworth School District acquired title to a certain parcel known as Block 276-L, Lot 64, ("the Parcel") pursuant to tax sale action and Sheriff's Deed; and

WHEREAS, the Parcel was publicly advertised for sale at minimum acceptable sealed bid of \$1,520; and

WHEREAS, Joseph and Barbara Cicchelli were the successful bidders by submitting the highest bid of ONE THOUSAND FIVE HUNDRED TWENTY DOLLARS (\$1,520); and

HEREAS, Article IV Section 2(1) of the Allegheny County Home Rule Charter vests County's Council with the power and duty by ordinance to convey real property owned by the County.

The Council of the County of Allegheny hereby enacts as follows:

SECTION 1.

The provisions set forth in the preamble to this Ordinance are incorporated by reference in their entirety herein.

SECTION 2.

- A. The County Council of Allegheny County hereby does approve the transfer of the interest held therein by the County of Allegheny in a certain parcel known as Block 275-L, Lot 64 to Joseph and Barbara Cicchelli for and in consideration of the sum of ONE THOUSAND FIVE HUNDRED TWENTY DOLLARS (\$1,520.00).
- B. The proper officers of the County are hereby authorized to execute any and all documents, including a deed, necessary to effectuate the conveyance of the County's interest in the Parcel.

- SECTION 3. If any provision of this Ordinance shall be determined to be unlawful, invalid, void or unenforceable, then that provision shall be considered severable from the remaining provisions of this Ordinance which shall be in full force and effect.
- SECTION 4. Any Resolution or Ordinance or part thereof conflicting with the provisions of this Ordinance is hereby repealed so far as the same affects this Resolution.
