**4612-09** Motion to approve the minutes of the January 7 & January 8, 2009 Health & Human Services Committee Meetings.

**IV. Agenda Items**

**Ordinance**

**4588-09** An Ordinance of the County of Allegheny, Commonwealth of Pennsylvania approving the disposition of personal property as set forth in a purchase offer memorandum dated October 31, 2008, from Administrative Resources, Inc. to the County of Allegheny.

**Sponsors:** Chief Executive

**Summary:** *Mr. Biondo provided the committee with a summary of the bill. He explained that the bill would convey stock from the County to Amerinet Central, a purchasing cooperative that the County joined for the purpose of purchasing medical supplies for the Kane hospitals and the Health Department.*

*He said that the County has been a dues paying member of a purchasing cooperative organized under the auspices of the Hospital Council of Western Pennsylvania known as Administrative Resources, Inc. (ARI) which does business under the name of Amerinet Central. He said that effective July 1, 2007, ARI converted from a Subchapter T cooperative to a Pennsylvania for-profit corporation and issued common stock to all of its dues paying members. During this process, the County was issued 17,333 uncertificated shares of common stock in ARI.*

**Action:** A motion was made by Futules, seconded by Green, that this matter be Affirmatively Recommended. The motion carried unanimously.
