

Please find the attached resume of Eddie Edwards, Jr., whom I am recommending for reappointment to the Allegheny County Port Authority.

The general purpose of the Port Authority is to operate an integrated transportation system for the purpose of moving large numbers of people safely, efficiently and economically. Today, PAT operates approximately 900 buses, 7195 light rails, Incline and ACCESS for the handicapped. I am recommending that Mr. Edwards serve a full five-year term which will end on December 31, 2013.

Mr. Edwards is an Associate with the law firm of Bums White and Hickton and concentrates his practice in the areas of business law, entertainment law and sports management. Eddie Edwards, Jr. is an Associate who concentrates his practice in the area of business law, entertainment law and sports management.
