Ordinance

An Ordinance of the County of Allegheny, Commonwealth of Pennsylvania amending Article 201, Section 5-201.05 of the Administrative Code to further define the powers, functions and duties of the Medical Examiner.

Summary: The Chair read the bill's title and deferred to Mr. Burn.

Mr. Burn noted that the bill makes a single addition to the duties of the Medical Examiner, allowing for the donations of organs by the Medical Examiner when a decedent is unidentifiable and/or the next of kin cannot be located. This was not included in the duties of the Medical Examiner when the office was created, although it was a duty that was conferred on the Coroner by state law.

Dr. Shakir noted that, although he does not specifically remember an instance in which this power would actually have been exercised, it is a good option to have available, so long as it is exercised judiciously.

The Chair asked if this bill in any way would circumvent or alter the will of the voters who authorized the creation of the Medical Examiner, and Dr. Shakir and Mr. Uber each answered that it would not.

Ms. Cleary indicated that she does think it could be a useful power to have, but does not think that it would be invoked all that often.

The Chair released the bill to the full Council.
