William Russell Robinson has been actively involved in the political process since 1974. A 1960 graduate of Schenley High School in Pittsburgh, he served on Pittsburgh City Council from 1978 to 1985. On Council, he chaired the Committee on Planning Housing and Development, the Supplies Committee and the Committee on Business Practices and Investment Policies.

A 1964 Ohio State University graduate, Robinson was elected to represent the 19th Legislative District in 1988, replacing K. Leroy Irvis. He serves on the Appropriations, Intergovernmental Affairs, and Tourism and Recreational Development committees, and on the Educational Committee as the Democratic Chairman of the Subcommittee on Higher Education. He has also served on the Health and Welfare, and Urban Affairs committees.

A lifelong resident of Pittsburgh, Robinson served the public long before his election to public office. In 1972, he earned a masters degree in political science from Duquesne University. Robinson taught at Point Park, Carlow College, the University of Pittsburgh and Community College of Allegheny County. He taught history, political science, African-American history, urban affairs and public administration.

Robinson is president of the Uptown Baseball Association, and secretary of the Martin Luther King, Jr. Cultural Center. He also is a member of the Women's Space East and Family Resources.
