

Dear Council Members:

Please find the attached resume of Jack Shea, whom I am recommending for appointment to the Allegheny County Sanitary Authority.

The Allegheny County Sanitary Authority's authorized powers include among others, the collection, transportation, treatment and disposal of sewage in Allegheny County, and certain adjacent areas and the collection, transportation, treatment and disposal of such industrial wastes as shall be acceptable to the Authority, within said territory. Mr. Shea will fill a vacancy on the Allegheny County Sanitary Authority. His term will end on December 31, 2007.

Mr. Shea is President of the Allegheny County Labor Council. Additionally Mr. Shea serves the community by volunteering on the Board of Directors of UPMC Health Systems, serving as Co-Director of the Three Rivers Labor Area Management Group, and also as a board member of the Catholic Youth Association.

Jack Shea, President Allegheny County Labor Council, AFL-CIO

Jack Shea is currently the Director of Organization for the IUE/CWA, AFL-CIO District 7, which covers 13 states. He was also the Director of the COPE (Committee on Political Education) for IUE in District 1, which covered 7 states from Pennsylvania down to and including Florida.

Jack began his union career in 1967, when he was on the organizing committee to form a union where he was employed, now known as IUE Local 630.

As he rose through the ranks of Local 630, he was first elected Shop Steward. In the next election, he was elected Chief Steward. In 1973, he was elected President of the IUE Local 630.

In 1971, Jack was the "Young Workers" Representative for IUE District 1.

From 1973 to 1975, Jack volunteered his own time to assist in the field of "organizing the unorganized" in the State of Pennsylvania.

In 1975, Jack was asked to join the IUE International Staff and for the next ten years, he worked all over the United States, servicing the already established IUE Locals and newly organized locals.

In 1985, Jack was appointed Co-Organizing Director of District 1 for the IUE. He retained this title until 1996, when he was appointed Assistant Organizing Director for the entire International Union.

Jack's involvement with the Allegheny County Labor Council, which represents 90,000 workers in the Allegheny County, goes back to 1985. He became one of the Vice-Presidents of the ACLC, AFL-CIO, and in 1990 he was asked to serve as their COPE Director.

In 1998, the ACLC Executive Board elected Jack to the position of Executive Vice-President.

On May 7, 1998, Jack was elected as President of the ACLC, to fill the term of the late Paul Stackhouse, Sr. He was then re-elected on December 3, 1998 for a two-year term.

On December 7, 2000, Jack was re-elected and is currently serving as President of the ACLC, AFL-CIO, for a term of five years.
