III. Approval of Minutes

4437-08 Motion to approve the Minutes of the October 14 & October 23, 2008 Budget & Finance Committee Meetings.

Action: **A motion was made that this matter be Passed. The motion carried unanimously.**

IV. Agenda Items**Ordinances**

4382-08 An Ordinance amending the Allegheny County Code of Ordinances, Division 1, entitled "Administrative Code," Article 808.A, in order to reduce the rate of County taxation on the sale at retail of liquor and malt and brewed beverages within the County.

Sponsors: Jim Burn, Joan Cleary, John DeFazio, Michael Finnerty, Amanda Green, Chuck Martoni, Bob Macey and Rich Fitzgerald

Summary: *Mr. Burn provided the committee with a brief summary of the bill. He said that the bill would establish the rate of County taxation on the sale at retail of liquor and malt and brewed beverages within the County at eight percent (7%). He said that the bill proposes a decrease of the rate of taxation by 3% from its current levy of 10%. He said that after studying the current drink tax revenues, 7% seemed consistent with the amount needed to provide a steady revenue stream to the Port Authority.*

Mr. Drozd spoke against the bill. He said that he thinks it makes the region less competitive.

Ms. Cleary spoke in favor of the bill. She said that even though surrounding counties do not have a drink tax their property tax has consistently gone up.

Mr. Gastgeb spoke against the drink tax in general. He said that he does not think that the bill reduces the tax enough and that he would like to see it lower.

Mr. DeFazio said that 7% is about as low as they could go. He said that according to some studies it may even be too low. He said that without the revenue from the drink tax the county would be forced to raise property tax.

(Robinson 2)

Summary: *The Chair offered an amendment to the bill. He explained that the amendment would eliminate the 2009 appropriation to the Port Authority, along with the corresponding transit revenues. He said that the amendment is designed to enable Council to retain oversight over the County's entire 2009 operating budget appropriations to the Port Authority.*

He also said that if the Port Authority wants this money released to them in 2009, they will need to make a request of Council for the release of any funding. The Port Authority will most likely be required to make specific disclosures regarding its "fiscal house" along with other conditions that this Council may impose for release of funding.

He said that he wanted to clarify that the intent of this amendment should not be confused as a lack of support for our transit system or its riders. He said that it is an attempt to place an additional level of accountability and oversight over an authority that is facing very serious issues that have the potential adversely affect the residents of this County. He said that his goal with this amendment is to protect the system.

Mr. Finnerty said that he believed that the amendment would just create another layer of bureaucracy which would delay operations and place Council in the middle of mayhem. He said that he thinks Council has the ability to accomplish this without the amendment.

Mr. McCullough spoke in favor of the amendment. He asked to be co sponsor of the amendment. Mr. Drozd also requested to be recognized as a co sponsor to the amendment.

Ms. Cleary, Mr. DeFazio, Mr. Macey and Mr. Gastgeb all spoke against the amendment.

There was no vote taken on the proposed amendment.
