






Please find the attached resume of Joe Natoli, whom I am recommending for appointment to the Allegheny County Parks and Recreation Commission ("Commission").

The purpose of the Commission is to advise the Director of Parks and Recreation on budget issues, fees and charges, personnel recruitment and training, and general operating responsibilities. Pending confirmation, Mr. Natoli will serve a term of two years as one of seven original members of the Commission. According to County ordinance, three original members serve terms of two years, and four original members serve standard terms of four years. The terms of all original members begin after County Council has confirmed the seventh and final member of the Commission, and expire at the end of the appropriate fiscal year. Mr. Natoli's term will therefore end December 31, 2005.

Mr. Natoli has served the parks within Allegheny County borders, and the community-at-large for over fifty years. As a parks professional and prominent community leader, he is undoubtedly qualified to serve as an original member of the Parks and Recreation Commission, especially in bringing the County's long tradition of parks and recreation into the present.

I appreciate your consideration, and ask you to act on this appointment as quickly as possible. Mr. Natoli will make himself available for review by County Council, if members of Council wish to speak with him.


