



Please find the attached resume of Council Member Joan Cleary, whom I am recommending for appointment to the Allegheny County Board of Health.

The powers and duties of the Health Board are set out in Section 12011 of Act 315, Local Health Administration Law, as amended. This Board shall exercise rule making power by formulation of rules for the prevention of disease, removal of conditions which constitute a menace to health and promote and preserve public health. I am recommending Ms. Cleary to serve a full 4 year term ending on January 11, 2012. Ms. Cleary will replace Council Member Jan Rea, who does not wish to be reappointed to this board.

Ms. Cleary is the Council Member representing District 6, a position she has held since 2004. Additionally, Ms. Cleary is a registered nurse, and has worked at Allegheny General Hospital for over 25 years. I believe her medical experience and governmental experience will be valuable to the Allegheny County Board of Health.

I appreciate your consideration, and ask you to act on this appointment as quickly as possible. Ms. Cleary will make herself available for review before the appropriate committee if members of Council wish to speak with her.
