





Please find the attached resume of Jeanne Antonuccio, whom I am recommending for appointment to the Penn State Cooperative Extension Board.

The Extension Board works in partnership with the staff of Penn State Cooperative Extension in developing, executing, and evaluating educational programs related to the total extension effort, including family living, agriculture, 4-H and youth development, community development and natural resources in Allegheny County. Ms. Antonuccio would fill a vacant seat on the Board and would serve until December 31, 2004.

Ms. Antonuccio is the Founder and President of About Pittsburgh, Inc., a private group that works with companies and individuals to familiarize relocating executives and their families with the Pittsburgh region. She founded this organization and has been president of it since 1987. Ms. Antonuccio is also very active in the community, as a current Board member for St. Edmund's Academy and Chairman of the Marketing Committee, and as a current Board member of Pittsburgh Technology Council HR Network. Ms. Antonuccio is also a past Board member of the Opera Theater of Pittsburgh and a past Chair of Public Relations and Communications for St. Nicholas Greek Food Festival. Ms. Antonuccio will bring greatly needed expertise in the areas of marketing, public relations and community outreach to the Cooperative Extension Board.

I appreciate your consideration and ask you to act on his appointment as quickly as possible. Ms. Antonuccio will make herself available for review before the full Council or the appropriate committee if members of Council wish to speak with her.
