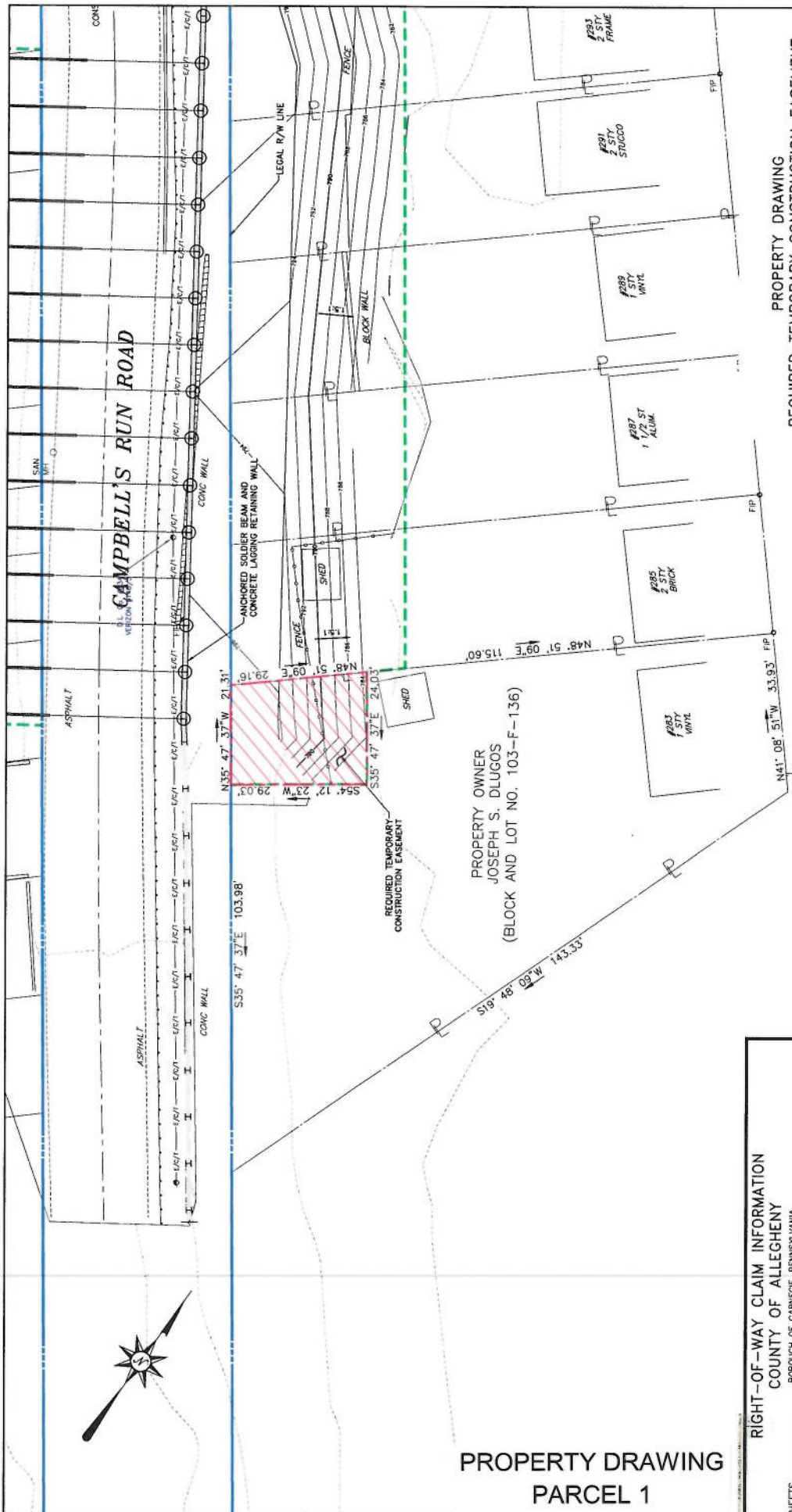

BLOCK AND LOT NO. 103-F-136

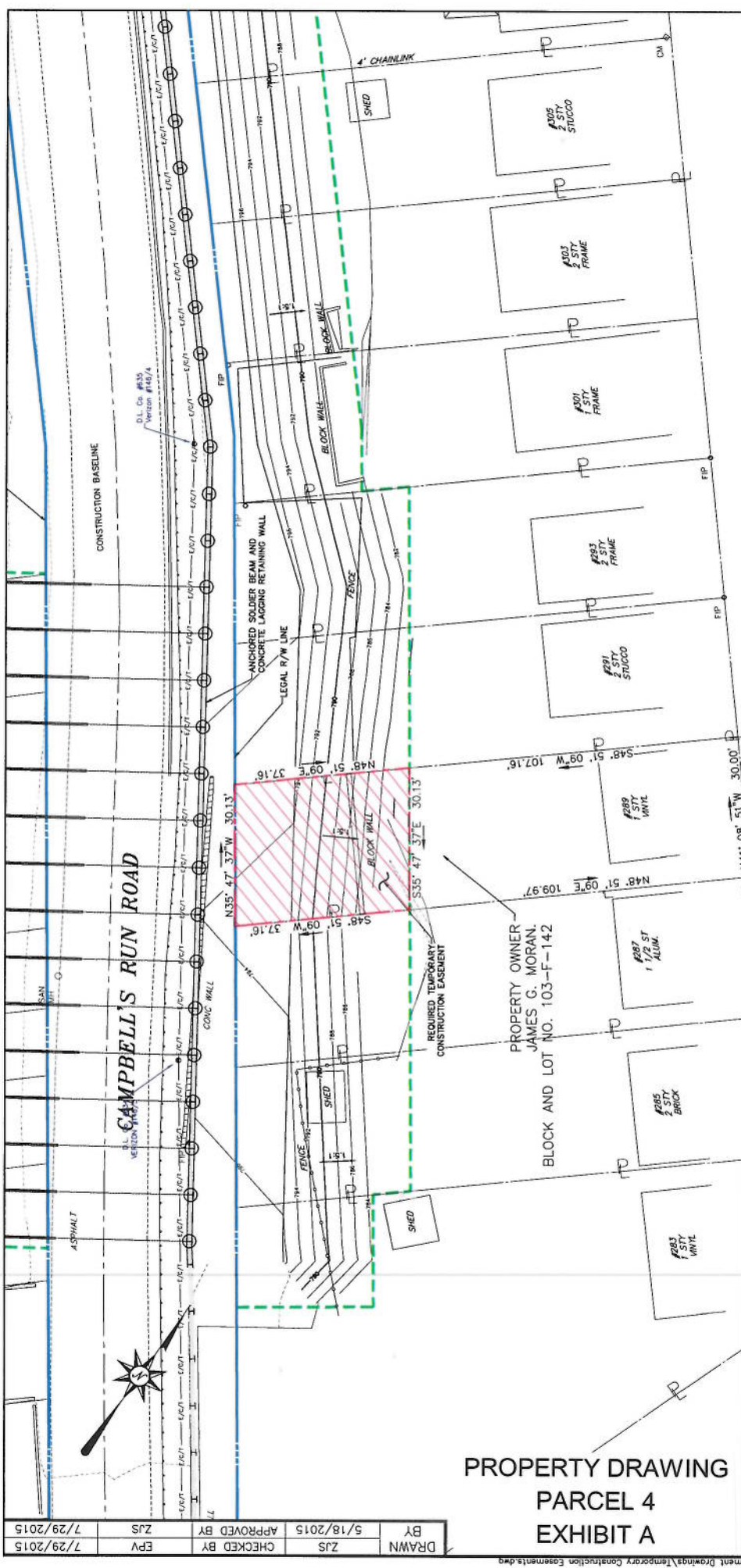

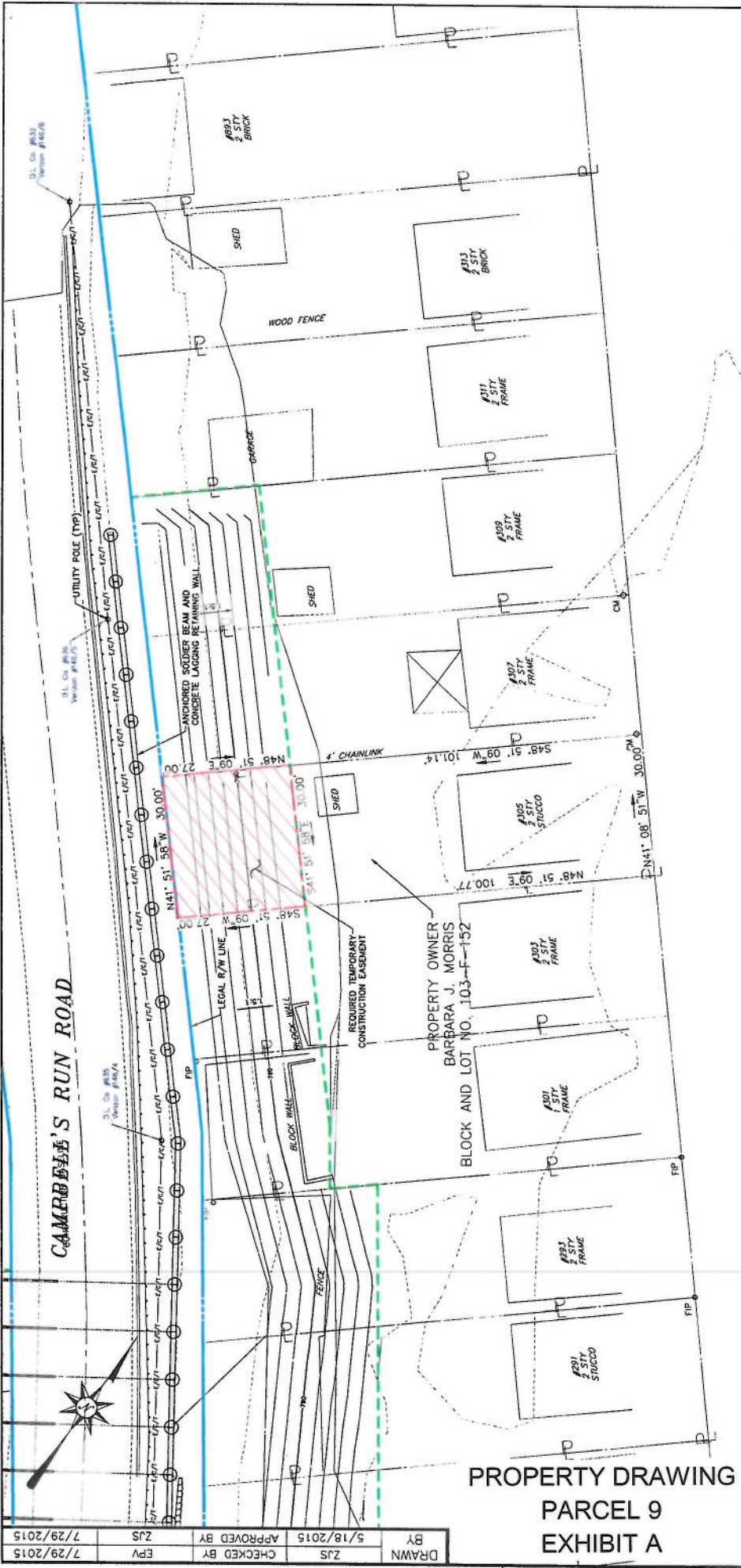
