






Please find the attached resume of Karen Kondos, whom I am recommending for appointment to the Drug and Alcohol Planning Council ("Council").

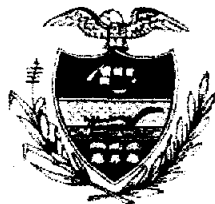
