




Dennis M. Davin assumed the position as director of the Allegheny County Department of Economic Development on March 10, 2004. In this capacity, he is responsible for overall economic development strategy and implementation for one of the largest urban counties in the United States. Davin manages 70 employees and more than \$75 million in local, state, and federal resources to implement community development, affordable housing, and new job creation initiatives for approximately 1.25 million citizens in 130 municipalities.

Prior to this position, beginning in July 2003, Davin held the position of Regional Director of the Governor's Action Team – Southwestern Pennsylvania. In this capacity, he worked directly with company executives interested in relocating or expanding in Southwestern Pennsylvania. Davin was responsible for underwriting incentive packages, coordinating cooperation between various economic development agencies, and determining overall impact of project proposals on the region and state economy for a ten-county region.

Davin gained significant economic development experience while employed at the Urban Redevelopment Authority of Pittsburgh. He joined the URA in 1987 after working in consumer lending for Mellon Financial Services. Davin managed Pittsburgh's single and multi-family development, rehabilitation, and mortgage programs for eight years before becoming the URA's housing director. As housing director, he designed and implemented housing policy for the City of Pittsburgh, while coordinating with federal, state, and local officials to secure funding for housing initiatives. Davin played an integral role in developing the Pittsburgh Housing Development Corporation, the City of Pittsburgh's nonprofit residential development arm, while serving as its deputy executive director.

Davin graduated from West Virginia University, Morgantown, W. Va., with a Bachelor of Science Degree in Business Administration. He is actively involved with the National City Bank Community Development Corporation Advisory Board, Greater Oakland Keystone Innovation Zone Board, and the National Association of Local Housing Finance Agencies, where he has served as the Board Treasurer and as an instructor for training workshops.

A native of Allegheny County, Davin lives in Bethel Park, Pennsylvania with his wife and three children. He volunteers his free time as a USA Certified hockey coach for the South Hills Amateur Hockey Association.
