WHEREAS, the Board of Directors of the World War II Veterans of Allegheny County Memorial Fund, Inc. has been meeting regularly to make this dream a reality, and is now ready to embark on a capital campaign; and

WHEREAS, the Allegheny County Council acknowledges that the war had a tremendous impact on the lives of thousands of people in this area, and further recognizes the importance of honoring those who fought to preserve and ensure our nation's freedom; and
