4517-08 An Ordinance of the County of Allegheny authorizing the County to enter into a cooperation agreement with the City of Pittsburgh, School District of Pittsburgh and Pittsburgh Water and Sewer Authority pursuant to the Pennsylvania Intergovernmental Cooperation Act for the purpose of jointly cooperating in the collection of Delinquent Taxes.

Summary: *The Chair said that a visual presentation and detailed discussion on this bill took place at the January 28, 2009 Government reform meeting. He said that the Controller had some concerns but those concerns have been resolved.*

4567-09

An Ordinance of the County of Allegheny, Commonwealth of Pennsylvania, amending and supplementing the Allegheny County Code of Ordinances, Division 2, entitled "County Government Operations," by the addition of a new Chapter 219 entitled "Campaign Finance Regulation."

Sponsors: Chief Executive

Summary:

The Chair said that a Public Hearing on this matter took place on February 25, 2009, but there seemed to be little interest from the public since only one person registered to speak. He described the differences between this bill and a similar proposed bill (4560-09). He said that Pittsburgh City Council is concerned that if this bill should pass it may apply to them. He said that his committee is in the process of obtaining a legal interpretation of this bill regarding that matter.
