

Dear Council Members:

Please find the attached resume of Orelia Vecchio, whom I am recommending for reappointment to the boards of Berg Manor Apartments, Broadview Apartments, East Pittsburgh Apartments, Pennshaw Apartments, Port Vue Apartments and Versailles Apartments, known collectively as the Section 202 Boards. These organizations were established to provide elderly and handicapped persons with housing facilities and services specifically designed to meet their needs. The boards of each organization share five individuals who sit on each of the boards, three of whom are appointed by the County. SUBJECT: **Section 202 Boards**

Per your request, I am submitting to you information on the Section 202 Boards. There are six (6) separate non-profit 202 Corporations that were sponsored by the now dissolved Housing Development Corporation. Action Housing, Inc. has assumed the non-profit sponsorship of the 202 Corporations. The Corporations are as follows:

- 1) East Pittsburgh Apartments
- 2) Pennshaw Apartments (Turtle Creek)
- 3) Versailles Apartments
- 4) Port Vue Apartments
- 5) Broadview Apartments (Pitcairn)
- 6) Berg Manor (Braddock)

The Corporations were organized specifically for the purpose to provide elderly persons and handicapped persons with housing facilities and services specifically designed to meet their physical and social needs. The Section 202 Housing program falls under the United States Department of Housing and Urban Development (HUD).

The Board of Directors consist of a maximum of seven (7) Directors. Five (5) Directors serve on all six (6) Corporation Boards. The remaining two (2) Board Members consist of one (1) Community Representative and one (1) resident of the Section 202 housing development owned and operated by the Corporation.

The Board of Directors are appointed as follows:

- 1) Three (3) members of the Board of Directors shall be appointed by the Chief Executive of Allegheny County.
- 2) Four (4) members of the Board of Directors shall be appointed by the Board of Directors of Action Housing, Inc.

The members of the Board of Directors shall serve a term of one (1) year and shall serve until their successors are duly appointed according to the above appointing sources.
