





Please find the attached resume of Edward D. Diggs, whom I am recommending for reappointment to the Minority, Women, and Disadvantaged Business Enterprise Certification Appeals Committee ("M/W/DBE Certification Appeals Committee").

The M/W/DBE Certification Appeals Committee serves as a due process vehicle to firms who have been denied certification as well as those facing de-certification as a M/W/DBE firm.
