AN ORDINANCE

ESTABLISHING A SPECIAL SHERIFF COMPUTER FUND ACCOUNT FOR FEES CHARGED AND COLLECTED BY THE SHERIFF'S OFFICE.

SECTION 1.

WHEREAS, the General Assembly of the Commonwealth of Pennsylvania by Act No. 47 of 2002 authorized the establishment of an additional fee for the initiation of any action or legal proceeding, to be used solely for the purpose of computerizing the Office of the Sheriff; and

WHEREAS, the Allegheny County Sheriff's Office is directed to establish a Special Sheriff Computer Fund Account for the deposit of this additional fee.

NOW, THEREFORE, THE COUNCIL OF THE COUNTY OF ALLEGHENY HEREBY ENACTS AS FOLLOWS:

The Allegheny County Council in accordance with Article IV, Section 2 of the Allegheny County Home Rule Charter hereby authorizes the establishment of a Special Sheriff Computer Fund Account on behalf of the County and requests that the appropriate parties execute the proper administrative processes for its creation.

SECTION 2.

If any provision of this Ordinance shall be determined to be unlawful, invalid, void or unenforceable, then that provision shall be considered severable from the remaining provisions of this Ordinance which shall be in full force and effect.

SECTION 3.

Any Resolution or Ordinance or part thereof conflicting with the provisions of this Ordinance is hereby repealed so far as the same affects this Resolution.
