





Please find the attached resume of David Miller, Ph.D., whom I am recommending for appointment to the Southwestern Pennsylvania Commission ("SPC").

The Southwestern Pennsylvania Commission is the cooperative forum for regional collaboration, planning, and public decision-making. As a regional public agency, the Commission develops plans and programs for public investments; satisfies federal and state requirements for transportation, economic development, and local government assistance programs; and operates with public involvement and trust. Dr. Miller will fill a vacant position on the Commission. His term will expire on December 31, 2006.

Dr. Miller brings deep knowledge of regionalism, metropolitan co-operations and inter-governmental issues to his work. He recently published a book entitled "Regional Governing of Metropolitan America" and is the Associate Dean of the Graduate School of Public and International Affairs (GSPIA) at the University of Pittsburgh. He served as managing director of the Pennsylvania Economy League, the Director of Management and Budget for the City of Pittsburgh and served as the representative to the Model Cities Charter of the National League of Cities.
