## Authorizing Inter-Departmental Budget Transfers 59 - 65.

## Section 1.

The following transfers totaling \$2,874,520 (Salaries \$1,996,354 and Fringe Benefits \$878,166) are approved as follows to pay for projected shortfall in salaries, fringe benefits and administrative costs due to required overtime incurred since September 11<sup>th</sup> for police services at the airports.
