## AN ORDINANCE

An Ordinance of the County of Allegheny, Commonwealth of Pennsylvania, establishing the tax levy upon all real property subject to taxation within the limits of Allegheny County.

## The Council of the County of Allegheny hereby enacts as follows:

#### SECTION 1.

In accordance with Articles IV and VII of the Home Rule Charter of Allegheny County, there is hereby established a levy of taxes on all real property subject to taxation within the limits of Allegheny County; said levy shall be 4.73 mills and used for the purpose of providing revenue for the payment of the ordinary current expenses and for the payment of interest and principal on the indebtedness of the County for Fiscal Year 2015.

#### SECTION 2.

The millage shall be allocated as follows:

County General Fund
County Debt Service Fund

3.9552 mills or \$.39552 per \$100 valuation 0.7748 mills or \$.07748 per \$100 valuation

#### SECTION 3.

Any change in the total levy shall require a 2/3 vote of the Seated Members of Council. The allocation between County General Fund and County Debt Service Fund may be changed annually by majority vote of the Seated Members of Council.

#### SECTION 4.

A discount of two percent (2%) shall be awarded for real property tax paid during the period from January 1, up to and including, March 31, 2015.

A penalty of five percent (5%) shall be added to the tax as of May 1, 2015. An interest charge of one percent (1%) per month calculated on the original tax shall be added commencing May 1, 2015, for every month and portion of month in which the tax remains unpaid.
