**4891-09** An Ordinance of the County of Allegheny, Commonwealth of Pennsylvania, authorizing the acceptance of donations of personal property by the Allegheny County Park Department.

**Summary:** *The Chairman read the title of the bill and invited Director Baechle to the table. Director Baechle provide the Committee with a description of the bill which authorizes the acceptance of two donations of plants for the South Park Greenhouse. The reason for this donation is the recent fire that destroyed the plants being grown in the greenhouse for use this season by the Parks Department.*

A Resolution closing out the Department of Conservation and Natural Resources Community Conservation Partnerships Grant Project (BRC-TAG-10-40), used in part to fund the Allegheny County Comprehensive Plan and, specifically, to fund the Parks, Greenways and Open Space Element of the Plan.

**Summary:**

*The Chairman read the title of the bill and then invited Deputy Director Hurley and Ms. Goswick to the table. Deputy Director Hurley provided the Committee with a description of the bill which is a requirement of DCNR to close out a \$300,000 grant. Once all close out requirements are met, DCNR will release the remaining grant balance of \$30,000 to the County. This grant was used in part to fund the Allegheny County Comprehensive Plan, and specifically, to fund the Parks, Greenways and Open Space element of the plan.*
