





Dear Council Members:

Please find the attached biography of Councilman Michael Finnerty, whom I am recommending for reappointment to the Conservation District Board.

The Conservation District was established in 1964 by a resolution of the County Commissioners, as stated in the Soil and Water Conservation District Law Act of 1945. This board provides technical advice on matters such as flood prevention; erosion and sedimentation; pollution control and preservation, development and improvement of agricultural land. I am recommending that Councilman Finnerty serve a term to expire on December 31, 2015.

November 2005, Michael J. Finnerty was elected to serve the constituents of District 4.

A graduate of Duquesne University, Council Member Finnerty is a retired educator, having taught in the Chartiers Valley School District for 30 years. Michael was President of the Chartiers Valley Federation of Teachers for two years. He also coached in Chartiers Valley school district for 23 years, including: Head Coach Girls' Basketball for eight years; Middle School Boys' Basketball for eight years; Middle School Football for 13 years; and, Middle School Track for 10 years.
