
Dear Council Members:

Stephan Broadus is assistant to the publisher at the New Pittsburgh Courier, one of the oldest and most historic Black newspapers in the United States. He is responsible for marketing and advertising sales, production, the Courier Web site, and is project director for the Pittsburgh Courier Archives photo collection.

He has over thirty-five years of progressively responsible leadership and management experience acquired in the media, private entrepreneurship, higher education administration and community service.

Committed to the community, Stephan recently completed an eight year term on the City of Pittsburgh Commission on Human Relations as 1st Vice President and Chair of the Compliance Review Section and an eight year term as a member of the Kingsley Association Board of Managers. He is a graduate of Leadership Pittsburgh Year VIII.

He was an original co-coordinator of B-PEP (The Black Political Empowerment Project), founder & chair of the Pittsburgh Branch NAACP Economic Development Committee, and editor of the Sojournal Truth (The Branch's Newsletter). Prior to rejoining the Courier in 2002, Stephan was senior vice president of North America Telecommunications Corporation, general manager at Renaissance Publications, and owned & operated a marketing, advertising and public relations firm. He was advertising manager at the Courier for eight years and worked at the University of Pittsburgh, the University of Missouri-St. Louis and Lindenwood University.

A native of Steubenville, Ohio, he has a Bachelor's degree from the University of Missouri-St. Louis.
