



Approving the reappointment of Timothy H. Johnson to serve as a member of the Retirement Board of Allegheny County for a term to expire on December 31, 2011.




Please find the attached resume of Timothy H. Johnson, whom I am recommending for reappointment to the Retirement Board of Allegheny County.
