Born and raised in the South Hills of Pittsburgh,I went to Alderson-Broaddus College as a biology/chemistry and physics major and achieved a 3.65 QPA. While in college, I worked as an intern for the US Fish and Wildlife Services researching benethic invertebrates on the Gauley River Project, was a member of the ZAG and Phi Delta Sigma Fraternities and maintained the college's greenhouse.

Upon graduation, I began my career in a management position with USS/American Bridge and worked at three of the nation's largest steel mills. When American Bridge was sold to acquire Marathon Oil, I moved back to Pittsburgh to renew my pursuit of a medical career as a biochemistry technician in Montefiore Hospital Nutritional Division.
