The Clerk read the title of the resolutions into the record and the Chair stated that they would be discussed together.

Mr. Strul was invited to the table along with Ms. Schultz to present a presentation on the TIF district for Westport Woods. Ms. Schultz reviewed a power-point slide presentation showing maps of the TIF districs and the projected tax revenue at full build out.

Ms. Danko joined the meeting.

Mr. Finnerty inquired regarding the amount of County Taxes that would be generated by the development.

Mr. Palmiere inquired as to the reimbursement schedule for the district. Mr. Strul stated that the interest rate on the debt is 3% but until tax bills are paid, there will be no "cash

flow" but upon that inception payments will come from the real estate tax payments generally twice a year.

Mr Finnerty inquired as to the named trustee. Mr. Strul clarified that RAC issues the debt, the obligor, and the "trustee" has not been named yet.

Mr. Finnerty asked for clarification on whether or not there would be a restraint on an assessment appeal within the agreement. Mr. Strul stated that the obligation of payment would remain the same no matter what the assessed value. The obligation remains on the developer to make a set payment regardless of value.

Mr. Strul made a correction from last meetings presentation. He stated that a number of projected local jobs created for the project will actually be 166 instead of the stated 180. Affirmatively Recommended
