Malley currently serves as business manager and financial secretary/treasurer for the Iron Workers Local No. 3 in Pittsburgh, PA. In this position he oversees the day-to-day business operations for the Local.

His acumen in the operational aspects of business have served him well, most notably as a member of the Ironworkers Local No. 3 Credit Union Board of Directors and board chairman from 1997 to 2005. He also serves as Vice-President for the Pennsylvania AFL-CIO Executive Committee and co-chair for the Spina Bifida Local Charity Golf Outing.

Since 1975 Malley has been an iron worker. Graduating in 1979 from the local's apprenticeship program he has helped to construct every major building in the downtown Pittsburgh area including Fifth Avenue Place, PPG Plaza, the CNG Tower and Oxford Towers. Additionally, he served as a journeyman on the construction of Heinz Field, PNC Park and the original David L. Lawrence Convention Center.

During his time as a journeyman he also served as an instructor in the local's apprenticeship program where he instructed approximately 400 current iron workers. Moving from the field to the office in 1996, Malley has served in every elected position within the local including Executive Board member, past president, financial secretary and treasurer and his current position. He was elected a full-time officer in 2002.
