

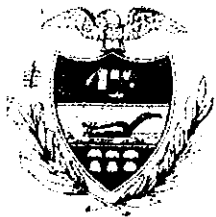
JUDITH S. BLACK, M.D., M.H.A.
