






Dear Members of Council:

Please find the attached resume of Thomas Donatelli, whom I am recommending for reappointment to the Allegheny County Port Authority pursuant to Pennsylvania Act 72 of 2013.

The general purpose of the Port Authority is to operate an integrated transportation system for the purpose of moving large numbers of people safely, efficiently and economically. Today, Port Authority provides about 70 million rides annually and operates a fleet of 1,000 buses, 83 light rail vehicles and two inclined planes while also offering ACCESS paratransit service. I am recommending Mr. Donatelli serve a 4-year term, which will expire on September 17, 2019. He was originally recommended by the Allegheny Conference on Community Development.

Mr. Donatelli is currently Vice-President of Western Pennsylvania Construction Management at Michael Baker Corporation. He previously served as the Allegheny County Director of Public Works.

I appreciate your consideration, and ask you to act on this appointment as quickly as possible. Mr. Donatelli will make himself available for review before the appropriate committee if members of Council wish to speak with him.

Thomas Donatelli, P.E. is presently Vice President of Business Development/Client Manager for Michael Baker international for the western Pennsylvania region. Tom was voted "Engineer of the Year in 1999" by the American Society of Civil Engineers' and "Pennsylvania Public Works Administrator of the Year in 2000". He received the "Distinguished Service Award" by the Pittsburgh Chapter of the Pennsylvania Society of Professional Engineers in 2011.

Mr. Donatelli has shared his extensive expertise in the field of civil engineering by serving as Adjunct Professor at the University of Pittsburgh. He has also taken leadership roles in professional organizations, such as the Construction Legislative Council, the American Society of Highway Engineers, and the American Public Works Association. He is the recent Past President of the Engineers' Society of Western Pennsylvania (ESWP) founded in 1880. ESWP has continually served as a focal point for the area's engineering and technical community and is currently Vice-Chairman of the Board of Directors for the Port Authority of Allegheny County.

He and his wife, Barbara, live in McCandless Township.
