





In March of 2004, Jennifer joined the Office of Allegheny County Council as Budget Director and in January of 2012, Jennifer was appointed to the position of Chief of Staff by Allegheny County Executive Rich Fitzgerald.

In addition to representing the County Executive on various boards and authorities, Jennifer currently serves as a Board Member of the Allegheny County Retirement Board, the Allegheny County Professional Services Review Committee, the Jail Collaborative Cabinet, the Riverlife Board of Directors, Pittsburgh Film Office Board of Directors, and the First Night Advisory Board.

Jennifer, a graduate of North Hills High School, attended the University of Pittsburgh at Johnstown where she received a Bachelor of Arts degree in Communications with a minor in Political Science. While in Johnstown, Jennifer served as a Congressional Intern for the late Congressman John P. Murtha, of Pennsylvania's 12th Congressional District. After graduating from Pitt Johnstown, Jennifer attended the University of Pittsburgh Graduate School of Public and International Affairs (GSPIA) where she earned a Master of Public Administration degree and a Professional Certification in Personnel and Labor Relations Management. Next, Jennifer attended Duquesne University's School of Leadership and Professional Advancement where she received a Professional Certification in Advanced Accounting.

Jennifer, a lifelong resident of Allegheny County, was born and raised in the Spring Hill neighborhood of the City of Pittsburgh's Northside and later moved to West View with her family. Jennifer currently resides in the Glenshaw neighborhood of Shaler Township with her husband Brian and children Caroline and Brenden.
