




Approving the appointment of Richard Gardner to serve as a member of the Drug and Alcohol Planning Council of Allegheny County for a term to expire on December 31, 2011.


Please find the attached resume of Richard Gardner, whom I am recommending for appointment to the Drug and Alcohol Planning Council of Allegheny County.

Worked as a field officer, primarily in the North Side, Northview Heights, Brookline, Hill District and Lawrenceville neighborhoods. Served as the lone line staff member on a statewide sentencing study group, 1976-77. Served as ACAPE (Allegheny County Association of Professional Employees) president 1976-78.
