





Please find the attached resume of Ms. Ellen Estomin, whom I am recommending for appointment to the Minority, Women, and Disadvantage Business Enterprise Certification Appeals Committee ("M/W/DBE Certification Appeals Committee").

The M/W/DBE Certification Appeals Committee serves as a due process vehicle to firms who have been denied certification as well as those facing de-certification as a M/W/DBE firm. 
