





REPRESENTATIVE NICK KOTIK, Democrat from Allegheny County, brings extensive public service experience to the House of Representatives.

After receiving a bachelor's degree in public administration from Indiana University of Pennsylvania in 1972, **REPRESENTATIVE KOTIK** went on to work for Allegheny County as a payroll accountant, municipal representative, and property assessor. Most recently, he served as assistant to State Representative **FRED TRELLO** and also as township manager for Robinson Township.

REPRESENTATIVE KOTIK held elected office as a borough controller and two-term council member and received many appointments, including president of the McKees Rocks Planning Commission, member of the Sto-Rox Bicentennial Committee, and ordinance officer and treasurer for McKees Rocks.

Currently, **REPRESENTATIVE KOTIK** serves on the Robinson Township Emergency Medical Services Board. He is actively involved in the community as a member of the McKees Rocks Development Corp., the William Penn Association, and the McKees Rocks Lions Club.

REPRESENTATIVE KOTIK lives with his wife, **SHIRLEY**, and two stepchildren, **TARA** and **DARRELL**.

His 2003-2004 General Assembly Legislative Sessions committee assignments are Aging & Older Adult Services, Health & Human Services, and Urban Affairs. He also received an appointment to serve on the House Policy Committee.

REPRESENTATIVE KOTIK's legislative priorities include continuing to improve transportation in his district and addressing the nursing shortage in Pennsylvania.


