
Dear Council Members:

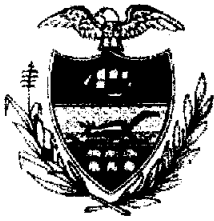
