**5088-09** A Resolution of the County of Allegheny amending the Grants and Special Accounts Budget for 2009 (Submission #15-09).

**Summary:** *Ms. Liptak provided members with a description of the amendment to the Grants and Special Accounts Budget for 2009.*

**Action:** **A motion was made by Macey, seconded by Chair Robinson, that this matter be Affirmatively Recommended. The motion carried unanimously.**

**5113-09** A Resolution of the County of Allegheny amending the Grants and Special Accounts Budget for 2009 (Submission #16-09).

**Sponsors:** Chief Executive

**Summary:** *Ms. Griser was invited to the table to discuss the amendment to the Grants and Special Accounts Budget for 2009.*

*According to Ms. Griser, as a result of the Pittsburgh G-20 Summit the County Police, Sheriff's Office, Jail, Courts, District Attorney's Office, Department of Public Works, and the Division of Computer Services incurred some costs. Ms. Griser listed the current estimate at \$2.5 million dollars, the majority of which is personnel costs. Chairman Robinson requested that Ms. Griser appear before the committee again once all of the G-20 figures are reconciled, and Ms. Griser agreed to meet with the committee in two weeks.*

**County Treasurer Weinstein will provide the Committee with an update on the County's 2009 revenue collections.**

**Summary:** *Mr. Weinstein provided members with a handout and presentation concerning the County's 2009 revenue collections.*

*In response to a question from Chairman Robinson, Mr. Weinstein stated the County does not have the ability to increase or decrease license fees since they are set by the state.*

*In response to a question from President Fitzgerald, Mr. Weinstein attributed the increase in real estate tax collections to new construction.*

*Mr. Weinstein replied to a question from Councilman Finnerty concerning the collection of the alcoholic beverage and rental vehicle taxes.*
