

Please find the attached resume of Charles P. McCullough, whom I am nominating to serve as Allegheny County Solicitor ("county solicitor").

As you are aware, the county solicitor is the chief legal office of the county and serves as the director of the county law department. Mr. McCullough is a shareholder at the Pittsburgh law firm Tucker Arensberg, where he has worked since 1995. He will take a leave of absence to serve as county solicitor. Mr. McCullough has also worked at several law firms, including Moorhead and Knox; Grogan, Graffam, McGinley, Solomon and Lucchino; and Karlowitz, O'Brien and Cromer. He was also general counsel at Navarra Insurance Services/T.M. Warwick and Co. I believe that Mr. McCullough's breadth of experience in municipal law, coupled with his commitment to our community and local non-profit organizations, makes him the right choice at the right time for a truly challenging position.
