**G-20 Status Update**

In the course of discussing the budgetary impact of the summit, Mr. Flynn distributed a spreadsheet of estimated costs & funding to the members and answered questions pertaining to the spreadsheet and funding arrangements.*

*In response to members' questions, Mr. Flynn discussed funding that has been identified to date and indicated that the County's public safety costs exceed identified funding by roughly \$500,000.*

*With regard to other expenditures, Mr. Flynn noted that public safety expenditures will be reimbursed first.*
