



Dear Council Members:

Please find the attached resume of Lidia Comini Turzai, M.D., whom I am recommending for reappointment to the Allegheny County Board of Health.

The powers and duties of the Health Board are set out in Section 12011 of Act 315, Local Health Administration Law, as amended. This Board shall exercise rule making power by formulation of rules for the prevention of disease, removal of conditions which constitute a menace to health and promote and preserve public health. I am recommending Ms. Turzai to serve another 4-year term ending on January 6, 2010.

Ms. Turzai currently serves as a full time pediatrician and partner at CCP-Pittsburgh Pediatrics. Additionally, she is an Associate Clinical Professor of Pediatrics at the University of Pittsburgh School of Medicine. She has served on the Board of Health since 2000.
