10039-17 An Ordinance of the Council of the County of Allegheny ratifying amendments to

Allegheny County Health Department Rules and Regulations pursuant to Section

12011 of the Local Health Administration Law, 16 P.S. §12001 et seq.

Sponsors: Chief Executive

At the request of the Chair, the clerk read the title of the bill and Dr. Hacker gave a brief overview of the proposed change, noting that the purpose is to modernize and streamline

the appeal and hearing regulations while making the procedure closer to those used by Commonwealth administrative agencies. Mr. Slater discussed the specific changes, noting the institution of the option for appointing a hearing officer, the regulations governing the appeal window, and discussing the changes to the hearing procedures.

Dr. Hacker noted that the proposed regulation was offered for public comment and that a handful of responses were offered, and that they were generally supportive of the changes. Mr. Slater discussed some of the comments that were received and the changes that were made in response, including changes to the rules relating to discovery, burden of proof, and the like.

In response to a question from Mr. Klein, Mr. Slater indicated that the new rule would be consistent with the procedures used by County and Commonwealth agencies that hear the same types of appeals.

A motion was made by Klein, seconded by Palmiere, that this matter be Affirmatively Recommended. The motion carried by a unanimous vote.
