






Please find the attached resume of Dave Mazzocco, whom I am recommending for reappointment to the Air Pollution Control Advisory Committee ("Advisory Committee").

The Air Pollution Committee recommends to the Board of Health additions and changes to the rules and regulations, and advises the Department and Board of Health on matters relative to the control of air quality in Allegheny County. Pending confirmation, Mr. Mazzocco will serve an additional one-year term, ending on December 31, 2003.

Mr. Mazzocco is being reappointed to the Advisory Committee after being recently reappointed to the brief remainder of a term. Although he is not a resident of Allegheny County, Health Department regulations allow for expert non-residents.


