A RESOLUTION

A Resolution of the Council of the County of Allegheny ratifying amendments to Allegheny County Health Department Rules and Regulations pursuant to Section 12011 of the Local Health Administration Law, 16 P.S. §12001 et seq.

Whereas, Allegheny County, pursuant to the Local Health Administration Law, 16 P.S. §12001 et seq., created the Allegheny County Health Department, and the Allegheny County Board of Health; and

Whereas, the Local Health Administration Law at Section 12011 provides for the Board of Health to adopt regulations and submit such regulations to Allegheny County for approval or rejection; and

Whereas, on November 3, 2004, Allegheny County Board of Health adopted the attached amendments to the Allegheny County Health Department Rules and Regulations, Article XV, Plumbing and Building Drainage, to thereby meet or exceed the plumbing requirements of the Uniform Construction Code and the International Plumbing Code; and

Whereas, it is the desire of Council to ratify the Allegheny County Health Department regulation amendments as approved by the Board of Health.

The Council of the County of Allegheny hereby resolves as follows:

SECTION 1. <u>Incorporation of Preamble.</u>

The provisions set forth in the preamble to this Resolution are incorporated by reference in their entirety herein.

SECTION 2. Ratification of Regulations

Acting pursuant to the Local Health Administration Law, County Council hereby ratifies the amendments to the Allegheny County Health Department Rules and Regulations, Article XV, "Plumbing and Building Drainage", attached hereto as Exhibit "A".

SECTION 3. Severability. If any provision of this Resolution shall be determined to be unlawful, invalid, void or unenforceable, then that provision shall be considered severable from the remaining provisions of this Resolution which shall be in full force and effect.

SECTION 4. Repealer. Any Resolution or Ordinance or part thereof conflicting with the provisions of this Resolution is hereby repealed so far as the same affects this Resolution.
