AN ORDINANCE

An Ordinance of the County of Allegheny, Commonwealth of Pennsylvania, authorizing acceptance of an Automated External Defibrillator from St. Margaret Foundation/UPMC St. Margaret, P.U.L.S.E. AED Program.

Whereas, St. Margaret Foundation/UPMC St. Margaret, P.U.L.S.E. AED Program has offered to donate an Automated External Defibrillator (AED) to Allegheny County Office of Public Defender for use in its Office and on Allegheny County property; and

Whereas, Article IV, Sections 2.j. of the Allegheny County Home Rule Charter vests the County's Council with the power to accept donations of personal property on behalf of the County.

The Council of the County of Allegheny hereby enacts as follows:

SECTION 1 ***Incorporation of the Preamble.***

The provisions set forth in the preamble to this Ordinance are incorporated by reference in their entirety herein.

SECTION 2. ***Acceptance of Automated External Defibrillator***

County Council does hereby authorize the acceptance an Automated External Defibrillator donated by St. Margaret Foundation/UPMC St. Margaret, P.U.L.S.E. AED Program. The appropriate County officers and officials are authorized to take such action as is necessary to carry out the purposes of the authorization granted herein.


SECTION 4. *Severability.* *If any provision of this Ordinance shall be determined to be unlawful, invalid, void or unenforceable, then that provision shall be considered severable from the remaining provisions of this Ordinance, which shall be in full force and effect.*

SECTION 5. *Repealer.* *Any Resolution or Ordinance or part thereof conflicting with the provisions of this Ordinance is hereby repealed so far as the same affects this Resolution.*
