
**Section 2.** The line item detail of the appropriations approved by Council shall be amended as reflected on Attachment A hereto, the provisions of which are incorporated herein by reference.

Eligible projects largely include affordable housing development through the redevelopment of foreclosed or abandoned properties or the reuse of vacant land. The Commonwealth of Pennsylvania was awarded nearly \$60 million in Neighborhood Stabilization Program funds from the U.S. Department of Housing and Urban Development (HUD).
