





Dear Members of Council:

Please find the attached resume of Stanley Gorski, whom I am recommending for reappointment to the Authority for the Improvements in Municipalities.

This Authority provides low interest loans to municipal governments and authorities to help them finance various capital needs including infrastructure, equipment and buildings. Grants are available for projects that are multi-municipal in nature, or impact a county facility. AIM also has the ability to issue tax-exempt financing, administer the distribution and investment of fiduciary funds, and provide deferred loans for special project activities. I am recommending Mr. Gorski serve another 5-year term which will expire on December 31, 2019.

Mr. Gorski is currently the Executive Director of the South Hills Area Council of Governments. He received his Bachelors, Masters and Juris Doctor Degrees from the University of Pittsburgh.

I appreciate your consideration, and ask you to act on this appointment as quickly as possible. Mr. Gorski will make himself available for review before the appropriate committee if members of Council wish to speak with him.
