AN ORDINANCE

An Ordinance of the County of Allegheny, Commonwealth of Pennsylvania, authorizing the donation of a John Deere Gator cart to the Morningside Baseball Association.

Whereas, Allegheny County has offered to donate to the Morningside Baseball Association a John Deere Gator cart for the purpose of dragging the infields, and hauling topsoil to the ball fields; and

Whereas, this equipment is no longer usable by the County.

The Council of the County of Allegheny hereby enacts as follows:

SECTION 1. Incorporation of the Preamble.

The provisions set forth in the Preamble to this Ordinance are incorporated by reference in their entirety herein.

SECTION 2. Authorization to donate Cart to Morningside Baseball Association

This Council hereby grants approval for the County to donate a John Deere Gator cart to the Morningside Baseball Association for the purpose of dragging the infields, and hauling topsoil to the ball fields.







Summary


