

Lisa Thorpe-Vaughn

Lisa Thorpe-Vaughn is Program Officer/Director of National Recruitment for Amachi. (*Amachi is a West African word meaning "Who knows what God has brought us in this child?"*) This position is overseen by the Founder/Director of the National Amachi Initiative; Rev. Dr. W. Wilson Goode, Sr., former Mayor of Philadelphia, Pennsylvania and Public/Private Ventures; a national nonprofit organization whose mission is to improve the effectiveness of social policies, programs and community initiatives.

In May of 2001, with honors, Lisa completed a Master's degree in English, with an emphasis in Intercultural Rhetoric, from Carnegie Mellon University. Lisa graduated from the University of Pittsburgh with a Bachelor degree in Business and Communication.

Lisa's previous position was as Executive Director of Amachi Pittsburgh, an initiative of the Pittsburgh Leadership Foundation (PLF) in partnership with other local non-profits, churches and agencies, which matches mentors from local congregations with children of incarcerated parents. Lisa led this city-wide network of "People of Faith Mentoring Children of Promise."



In its first year Amachi Pittsburgh received presidential recognition at the 1st National Conference for the Whitehouse Office of Faith/Community-based Initiatives, as one of eight programs nationally who are successful at President George Bush's "Compassion In Action".

In addition to Amachi Pittsburgh Lisa served as the Chief Program Officer and the Director of Training for the PLF. The Chief Program Officer was responsible to the President for providing administrative oversight to all projects, maintaining strategic alliances with partner organizations and fund development.

Annually in her role as Director of Training, Lisa organized/presented a national training institute for the Leadership Foundations of America (LFA). The intended outcome of this event was to provide quality training, promote national speakers, showcase national best practice models, and provide networking opportunities for established as well as up-and-coming leaders.

In 2004 Lisa was showcased locally as one of Pittsburgh's "*50 Women of Influence*" as a woman who continues in service while balancing a family and career. Lisa received national recognition in the Fall 2005 edition of the Precious Times magazine as one of "*The 50 Faithful*" (people doing the work that God appointed so that His will is done on earth).

Adding to her work experiences Lisa served as Program Manager for The Mentoring Partnership of Southwestern Pennsylvania, specializing in faith-based and community-based programs. While with The Mentoring Partnership, Lisa developed the Church Based Mentoring Network (CBMN), a volunteer organization with over fifty local churches actively involved in mentoring.

In addition to these career positions, Lisa mentors a group called Junior Noblewomen, a mentoring program for pre-teen/teenage young women in Pittsburgh's inner city.

Lisa is a licensed evangelist/missionary in the Church of God in Christ, worldwide. She and her husband, Elder James Vaughn, met through their responsibilities as leaders in their respective churches. They have been married 15 years and are active in Northside Institutional C.O.G.I.C. (where both of Lisa's parents have been pastors for more than 35 years). They have two children, JaLisa (14) and Carrington (10).
