3151-07 An Ordinance of the County of Allegheny approving adoption of the Allegheny

County Health Department's Rules and Regulations, Article IV, Smoking

Regulations.

Mr. Westman provided the committee with a summary of the bill. He said that the Board of Health adopted this amendment and in compliance with the Local Health Administration Law, the Director of the Health Department has submitted the amendment to the Chief Executive, with a recommendation for approval by County Council.

He further explained that this amendment incorporates a few facially minor additions to the State Implementation Plan relating to solid waste incineration units. These additions appear to be aimed primarily at clarifying the inclusion of "air curtain incinerators" within the regulation.

The Chair asked Mr. Westman if these regulations will be more stringent than the Federal government's. Mr. Westman said no.

The Chair asked Mr. Westman how the air curtain incinerators would operate. Mr. Westman provided the Chair with that information.
