



Approving the reappointment of Dennis J. Simon to serve as a member of the Authority for the Improvements in Municipalities for a term to expire on December 31, 2012.




Please find the attached resume of Dennis J. Simon, whom I am recommending for reappointment to the Authority for the Improvements in Municipalities.

This Authority provides low interest loans to municipal governments and authorities to help them finance various capital needs including infrastructure, equipment and buildings. Grants are available for projects that are multi-municipal in nature, or impact a county facility. AIM also has the ability to issue tax-exempt financing, administer the distribution and investment of fiduciary funds, and provide deferred loans for special project activities. I am recommending that Mr. Simon serve another 5 year term, which will expire on December 31, 2012.

Mr. Simon is the Third Vice President of the Allegheny County Boroughs Association, and a member of the Turtle Creek Valley Council of Governments. Additionally, Mr. Simon is the President of East Pittsburgh Borough, a position he has held since 1995. Mr. Simon is also involved with the East Pittsburgh Civic Association and the East Pittsburgh Economic Development Corporation.

I appreciate your consideration, and ask you to act on this appointment as quickly as possible. Mr. Simon will make himself available for review before the appropriate committee if members of Council wish to speak with him.
