


Please find the attached resume of Mr. Robert Hester, whom I am recommending for reappointment to the Allegheny County Conservation District Board ("Conservation District Board").

Mr. Hester currently serves the Conservation District Board as its Chairman. His continuing contributions to and leadership of the Board validate his reappointment.

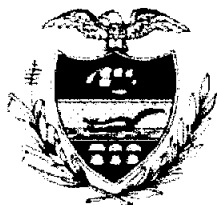
